Instructions

You have the right to withdraw from a contract concluded through our service within 14 days without giving any reason.

To meet the withdrawal deadline, it is sufficient for you to send your communication concerning your exercise of the right of withdrawal before the withdrawal period has expired. In the event of withdrawal from this contract, we shall reimburse all payments received from you without delay and in any event not later than 14 days from the day on which we are informed about your decision to exercise your right of withdrawal from this contract. We will reimburse you using the same means of payment as you used in the original transaction, unless you have expressly agreed otherwise; in any event, you will not incur any fees in connection with this reimbursement.

Information on the processing of personal data

The administrator of the personal data provided in the form is the addressee of this declaration. The data are processed for the purpose of handling the withdrawal process, which is our legitimate interest as referred to in Article 6(1)(f) of the GDPR, and is also the fulfilment of a legal obligation pursuant to Article 6(1)(c) of the GDPR in connection with the relevant legal provisions on withdrawal.
